## **WE NEED YOUR HELP**

We are asking customers to use water efficiently during the Hinkle Reservoir project (November – April), and turn off outdoor irrigation systems, if possible. These actions will reduce demands on the system while we have limited water storage available. Your retail water agency may have additional recommendations, which you can find on their websites listed below.

In November 2022, San Juan Water District will start replacing the cover and liner on the 62-million-gallon Hinkle Reservoir, located next to Folsom Dam. The cover and liner protect your water supplies from contamination.

This facility is the primary water storage for the water agencies that San Juan serves:

- · Citrus Heights Water District
- · Fair Oaks Water District
- Orange Vale Water Company
- City of Folsom north of the American River
- · San Juan's Retail Service Area

The existing cover and liner were installed in 1980 and have reached the end of their lifespan. This is one of the largest and most complex infrastructure projects that San Juan has undertaken in the last four decades.

San Juan will take the reservoir offline in mid-November and will switch to using two temporary, one-milliongallon storage tanks located on San Juan's campus. The temporary storage tanks will be San Juan's sole storage in the wholesale surface water supply system until we complete the project, projected to be in April 2023.


