# Position Description Meter Technician

Status: Non-exempt, Non-Safety Sensitive

**Supervisor:** Customer Service Manager

## **Supervision Received and Exercised**

Receives direct supervision from the Customer Service Manager. Does not provide supervision to others.

#### **Primary Function**

Read and record consumption for retail water meters; respond to customer requests and inquiries related to metering; and identify, record and perform minor maintenance and repairs on metering equipment.

**Essential Duties** - Depending upon assignment, duties may include, but are not limited to, the following:

- Read and record District retail meters manually and with hand-held equipment.
- Read and record District facility meters.
- Read and record District wholesale meters where interties exist with wholesale agency customers.
- Review consistency of meter readings; ensure that meters register data accurately; report high/low meter reads.
- Organize routes to accommodate new meters and update existing routes.
- Obtain re-reads and other requested reads.
- Tactfully and politely respond to customer concerns and inquiries related to meter service and reads.
- Perform minor maintenance and repairs on meters.
- Test meters for accuracy as needed.
- Clear meter boxes from landscaping, brush, overgrowth and other obstacles.
- Mark meter locations and other identifiers on pavement and meter box lids using waterproof paint.
- Assist with customer notifications and shutoffs as needed.
- Assist Field Services as directed.
- Work cohesively with Customer Service in resolving issues related to meters and meter reads.
- Research and assist in the evaluation of meters and meter reading equipment.
- Perform water audits by zones as directed.
- Correspond to customers verbally and in writing.

- Prepare simple reports.
- Ensure meters are registering properly.
- Repair and/or report service leaks and malfunctioning meters.
- Identify and report unusual meter conditions, defects, leaks and/or suspicious conditions, including unauthorized connections.
- Follow the District's safety standards.
- Perform monthly inspections on meter reading vehicles.
- Perform related duties as assigned.

## **Minimum Qualifications**

## Knowledge of:

- District policies, rules, regulations and procedures related to position.
- Utility meters, meter reading/recording devices and related equipment.
- Code of Ordinance related to water service.
- Basic mathematical principles.
- Effective and tactful communication techniques.
- Occupational hazards and standard safety practices.
- Common public relation courtesies, practices and techniques.

#### Ability to:

- Proficiently and accurately read meters.
- Operate and maintain metering equipment and tools.
- Prepare and maintain metering records.
- Work outdoors in all weather conditions with exposure to dust, dirt, water and significant temperature variations.
- Quickly learn District geography, street locations, and location of meters.
- Deal tactfully and courteously with the public.
- Perform assigned duties under general supervision in an independent manner according to overall directives within the context of established guidelines.
- Effectively communicate, both orally and in writing.
- Establish and maintain effective working relations with the public and District staff.
- Utilize strong analytical skills.
- Proficiently utilize a computer and applicable software.
- Utilize trouble shooting and diagnostic techniques.
- Maintain and repair meters and/or report to appropriate personnel as required.
- Prepare simple reports and spreadsheets.

## Experience, Education, Licenses and Certificates:

Any combination of experience and training that would provide the required knowledge and abilities is qualifying. A typical way to obtain the required knowledge and abilities would be:

# Required:

- Exposure to working with the public.
- High school diploma or equivalent with the ability to read and write at a level necessary for successful job performance.
- Valid California Driver's License issued by the California Department of Motor Vehicles.
- Proof of good driving record.

### Desirable:

• Some experience reading and maintaining utility meters is desirable.
